Break Bumpers

'Beginning of Parts' and 'End of Parts' consist of the programme title only (not series or strand titles). They should be included in the programme duration and be 3 seconds in duration.

Part numbers should NOT be used (e.g. "Part 3" or "End of Part 3"). The title can be over action, black or a still.

For the 'Beginning of Part' - audio will need to start at +12 frames.

For the 'End of Part' audio must be faded to silence before the out point and the vision held for a further 5 seconds.
