

1. The following terms set out the agreement between you, the Participant and Mothership Productions Ltd, for your application to participate in the Series which we propose but do not undertake to produce.
2. To make this application you must be (a) aged 18 years or over, (b) a permanent legal resident in the United Kingdom, Isle of Man or the Channel Islands and must currently be living in the United Kingdom, Isle of Man or the Channel Islands, and (c) willing to release yourself from family and/or work commitments on request by us on a specified date.
3. You must be able to commit to all the filming days required for the Series, which we estimate will be between the beginning of April 2023 and end of June 2023 and will include 6-7 weeks non-stop travel abroad. Should your application be successful, we will confirm the arrangements for filming and the relevant dates nearer the time.
4. As part of the application for the series, you are required to provide complete, valid, correct, and up-to-date information, (including information regarding any criminal charges, convictions, or proceedings), and to verify this information, Mothership may carry out thorough background checks and you agree to provide any assistance to carry such checks.
5. In order to confirm you are fit to take part in the series, you may be required to undertake one or more medical checks/consultations and/or provide contact details of your GP so a designated member of the team/expert may gain access to your medical records for the sole purpose of confirming your health and wellbeing for the series.
6. You warrant that any contribution, submitted by you as part of your application, in whatever form, including any written material, video, live zoom interviews and photographs:
  - a. is true, genuine, accurate and original to you.
  - b. has not been copied or reproduced from any third party
  - c. will not in any way be defamatory, obscene, unlawful, harmful, offensive, or inappropriate.
  - d. does not infringe the copyright or any other right of any third party; and
  - e. does not breach any contract, duty of confidence or right of privacy.
7. By contacting Mothership via the application process, you are consenting to Mothership holding and processing personal and sensitive personal data relating to you in any form, whether electronically or otherwise, provided that at all times, Mothership complies with data protection law and best practices.
8. Whether or not you are selected to take part in the Series or remain actively involved in the Series, you must at all times keep all information about the Series strictly confidential and must not share any information or material or make any public statement or publish any photographs at any time by any means (including on blogs, websites and/or social networking platforms such as Twitter, Facebook etc.) regarding the application or production process and/or the Series or any other person involved in such processes. This confidentiality applies and continues. You are not permitted to respond to any approach from the press or anyone else enquiring about the application or production process, anyone else involved in the process and/or anything about the Series and will refer any such enquiries immediately to Mothership.
9. Mothership's decisions regarding the application and audition process and the selection of applicants for the Series are entirely at our sole discretion, final and binding.

10. If your application is successful and you are chosen to take part in the Series, you will be asked to sign a Contributor Agreement, which will set out in detail the terms of your participation in the series.
11. Your personal data is very important to us. All the information you supply will be collected and processed in accordance with all laws and regulations relating to the protection of personal data, including the General Data Protection Regulation ((EU) 2016/679).
